DYNAMIC offers a one (1) year, limited warranty on all Dynatrap Insect Traps. The Dynatrap models that are included in this warranty include the model numbers DT150, DT250IN, DT500IN, DT300IN, DT1000, DT1050, DT1100, DT1200, DT1250, and DT2000XL. DYNAMIC warrants to the original purchaser that the product is free from defective materials and workmanship. This warranty is limited to remedy any defective part for a period of one (1) year from the date of original purchase. Retain your original receipt as proof of purchase. If a defect covered by this warranty occurs during the one (1) year warranty period, DYNAMIC at its own option and discretion will repair or replace, at no charge, any part that DYNAMIC determines to be defective.
