

## Limited One Year Warranty

Roberts warrants that if this product fails under normal use within one year from the date of purchase due to a defect in workmanship or materials, Roberts will repair and/or replace it free of charge if the product is returned to the retailer/distributor where it was originally purchased. Any claim under this warranty must be made within one (1) year of the date of purchase of the product. To make a claim under the warranty, take the product with proof of purchase (receipt) to the store where you purchased the product or contact Q.E.P. Co., Inc. or one of its subsidiaries in your country of purchase. This warranty is provided in addition to other rights and remedies you have under law and is applicable within the country of purchase.

Our goods come with guarantees which cannot be excluded under the Australian Consumer Law. You are entitled to replacement or refund for a major failure and to compensation for other reasonably foreseeable loss or damage.
