PROOF OF PURCHASE (original sales receipt) MUST ACCOMPANY ALL WARRANTY CLAIMS. IF YOUR ORIGINAL RECEIPT IS USED TO OBTAIN A PROMOTIONAL REBATE ON THE PRODUCT, A COPY OF THE RECEIPT ALONG WITH A COPY OF THE REBATE FORM MUST BE SUBMITTED WHEN REQUESTING WARRANTY SERVICE.
