ecoSAVER WARRANTY

- Horizon warrants it's ecoSAVER solar panels for 5 years from the date of purchase on a pro rata basis with terms
 and conditions described below and extends this limited warranty to the original retail purchaser.
- 2. From the date of purchase and for the next 5 years the following pro rata schedule applies:
 - Year 1 full warranty replacement
 - Year 2 purchaser pays 50% Of suggested list price at time of replacement
 - Year 3 purchaser pays 60% Of suggested list price at time of replacement
 - Year 4 purchaser pays 75% Of suggested list price at time of replacement
 - Year 5 purchaser pays 90% Of suggested list price at time of replacement
- After the prepaid return of a solar panel to Horizon at it's location in Chicago IL, Horizon will at it's sole discretion
 repair or replace any solar panel found to be defective in material or workmanship subject to the limitations and
 exclusions listed below.
- 4. Horizon does not warrant any damage to the solar panels or failure of the solar panel system due to:
 - Improper installation or failure to follow the instructions provided by the manufacturer;
 - Freezing caused by improper winterization, drainage or storage of the solar panel system;
 - Damage caused by or related to repair or alterations performed by any service other than those authorized by Horizon:
 - Improper handling or misuse of the product, or use for any other purpose than for which it was intended.
- Horizon does not warrant any parts that are deemed consumable such as "O" Rings, Nylon Straps and Plastic Hose provided by other manufacturers.
- This warranty does not constitute either a performance or satisfaction guarantee. It is the responsibility of the product owner to regularly test and check the product for proper function and safety.
- 7. Any parts sent to Horizon and returned to the purchaser shall be removed and installed or reinstalled at the owner's expense. Under no conditions will Horizon or Dealer be responsible for labor charges, loss of water or chemicals. The purchaser must prepay freight charges for any parts sent to Horizon for repair or replacement. Freight charges for the return of parts to the purchaser shall be paid by purchaser.

 purchaser on the original retail receipt and no rights accruing to the original purchaser under this warranty shall be
 assigned to any subsequent purchaser.
