Refrigerators (Built-In models PSB42LSR and PSB42LGR)

For The Period Of	GE Will Replace
Two Years From the date of the original purchase	Any part of the refrigerator which fails due to a defect in materials or workmanship. During this full two-year warranty , GE will also provide, free of charge , all labor and in-home service to replace the defective part.
Five Years From the date of the original purchase	Any part of the sealed refrigerating system (the compressor, condenser, evaporator and all connecting tubing) which fails due to a defect in materials or workmanship. During this full five-year sealed refrigerating system warranty , GE will also provide, free of charge , all labor and in-home service to replace the defective part in the sealed refrigerating system.
Sixth through Twelfth Year From the date of the original purchase	Any part of the sealed refrigerating system (the compressor, condenser, evaporator and all connecting tubing) which fails due to a defect in materials or workmanship.
