If your WORX tool becomes defective due to faulty materials or workmanship within a period of 3 years* from the date of purchase, we guarantee to:

- Replace or repair all defective parts, free of charge**, or,
- Repair products free of charge**, or,
- Replace the unit with a new or re-conditioned unit, free of charge**.

Your warranty is subject to the following conditions:

- Registration online at www.worx.com
- Battery packs and chargers are guaranteed for a 12 month period only, regardless of online registration.
- The tool has not been misused, abused, neglected, altered, modified or repaired by anyone other than an authorized service center.
- Only genuine WORX accessories and parts have been used on or with the product
- The tool has been subjected to fair wear and tear.
- The tool has not been used for trade or professional purposes.
- The tool has not been used for rental purposes.
- The tool has not sustained damage through foreign objects, substances or accidents.
- The tool was not purchased prior to January 1st, 2013. (*Purchases made prior to 2013 will be subject to a 2 Year Limited Warranty.*)

Your warranty does not cover:

- Abnormal use, abuse, neglect, accidents, alteration or repairs by other than approved service centers.
- Normal tool wear and tear and professional, trade, or rental use.
- Components that are subject to natural wear and tear caused by use in accordance with operating instructions.
- Unauthorized/improper maintenance/handling or overload is excluded from this warranty as are accessories such as bulbs, blades and bits, etc.

For Service:

Additional Limitations

Any implied warranty granted under state law, including warranties of merchantability or fitness for a particular purpose, are limited to three years from the date of purchase.
